How do I make or change a Will?

We strongly encourage you to discuss your Will and wishes with your loved ones. This ensures you are well supported through the process and your wishes are met. It's best to consult with a solicitor to make your Will. We cannot provide legal advice as we are not legal professionals. We recommend speaking with your solicitor to make any changes to your Will.

Is there a 'best type' of gift?

Most of our supporters choose to leave a 'residual' gift. This is a percentage of the remainder of your estate after loved ones have been taken care of. A residual gift holds its value over time, keeps up with inflation, and automatically adjusts to changes in the value of your estate, minimising the need to change your Will at various times. Even a gift of 1% of your estate, where your loved ones get the other 99%, will make an immense difference in transforming women's lives.

You can also choose to leave a specific dollar amount, called a 'pecuniary' gift.

What wording should I use?

We do not specify the wording you should use as we are not legal professionals. All your solicitor will need to include a gift to Biyani House in your Will is our ABN (ABN 65 351 615 350), and registered name, Biyani House Revesby Women's Shelter.

To ensure gifts have the greatest impact where they're most needed, our preference is for gifts to be directed to 'the general purposes of Biyani House Revesby Women's Shelter'.

Do I have to tell you about my gift?

We appreciate some people may prefer to keep their intentions private. Your Will is very personal so it's completely up to you whether you'd like to tell us, and we respect your wishes.
